<Reviewer 1>

Introduction

The introduction is a bit long and reads more like a literature review. I feel like it could be half the length and discuss your study more. Your study only gets a brief mention at the end of the introduction, and I am none the wiser as to the contents of the study after reading it.

Lit review

The digital native/immigrant statement needs a bit more work. Since 2001 many studies have actually dismissed this idea, and while it is fine to follow Prensky I think there needs to be mention of the opposing arguments.

"Arguably, one of the most popular approaches in integrating educational technology to language learning is digital game-based learning (DGBL). In addition to the prevalence of digital gaming as a leisure activity, in the past few years, digital games have also been integrated in classroom practices for language education (Yang et al, 2020)"

"Arguably" Very much so. There is a lot of resistance to DGBL which doesn't appear here.

"Past few years" More like the last couple of decades

"Arguably" Very much so. There is a lot of resistance to DGBL which doesn't appear here.

"Past few years" More like the last couple of decades

DGBL v Gamification You seem to be mixing the two a bit here. I think you should highlight the differences between the two.

Again, you only seem to reflect on the positives. This makes it seem like DGBL is the magic pill to all language learning issues. Please make the literature review a more balanced reflection of the current literature.

Raitskaya & Tikhonova., 2019 - no period needed

(Wright et al., 2005) - very old reference. A lot more has happened since 2005

"Most of these studies have reported positive findings favoring the adoption of gamification for vocabulary learning in different EFL settings such as China, Taiwan, Korea, Saudi Arabia, Thailand, and Indonesia". – again switching between DGBL and gamification

Quizlet – is not a game

Baicizhan – is not a game. At best it is an educational language learning application that has game like drills

Li, R., Meng, Z., Tian, M., Zhang, Z., & Xiao, W. (2019) doi doesn't work

By this point in the lit review, I am very confused. Are we talking about the gamification of DGBL?

Quizlet then Quizlet® - be consistent

The English in the final paragraph is a bit awkward. "To put it in other words, there were rare studies" I can understand what you are trying to say, but I think you need to have a native speaker edit this entire paragraph.
