This Memorandum of Understanding to promote the education, academic and cultural cooperation will be valid for the period of 5 years and is subject to revision, renewal or cancellation by mutual consent and shall be implemented in the form of Memorandum of Agreement which explain in details the rights and obligations of each party.

This Memorandum of Understanding becomes effective upon completion of signature.

First Party and **Second Party**, for next can be named as **The Parties**, firstly explain the points below:

- The **First Party** will hold an event named **India – Indonesia Photo Exhibition** which will be held on **25th – 29th November 2013** in **State Islamic Institute of North Sumatra**, here in after referred as the 'Event'.
- The **First Party** will hold as the **Event Organizer**.
- The **First Party** has bargained with the **Second Party** as the sponsorship and partnership according to this Event.
- The **Second Party** agrees to be the sponsorship and partnership on the **Event** which will be held by the **First Party**.

Upon the list above, **The Parties** agree to share their rights and responsibilities on the **Agreement of Cooperation** on the event **India – Indonesia Photo Exhibition** (for next can be named as 'Agreement'), with the requirements and terms below:

Article-1

Scope of Work

1. The **First** and **Second Party** agrees to share responsibilities to conduct the Event on 25th – 29th November 2013, at State Islamic Institute of North Sumatra, Medan
2. The execution of the Event mentioned in the point (1) would be in accordance with the rundown of the Event (enclosed) as agreed by both parties. The sharing of right and responsibilities of both parties is as follows:

Article-2

Cost and Activities Budget

The cost for conducting this Event will be paid each party in accordance to scope of work mentioned in article 1. Both parties agree to communicate and coordinate work to ensure timely deliverable on the venue during the Event.

Article-3

Force Majeure

1. Force Majeure in this agreement shall be any of the following Events an act of God, earthquake, sustained rioting, war, insurgence, general strike or other Governmental restriction or any other Event beyond the responsibilities of The Second Party, causing The Second Party to be unable to implement the works.
2. The Second Party is obliged to notify The First Party on the occurrence of said force majeure in writing, 14 (fourteen) calendar days at the latest, after the occurrence of the force majeure condition, which shall be accomplished by statement and confirmation from the competent Government Agency in the jurisdiction where the Event of force majeure occurs.
3. The Second Party is prevented by force majeure from carrying out any obligation hereunder, the obligation of The Second Party shall be suspended until the force majeure Event is over

Article-4

Modification to the Agreement

If a condition arises, which requires modification, improvements or alterations of this agreement, the said changes shall be made by mutual agreement in writing and set forth in the form of an amendment of this agreement.
